# LIMITED WARRANTY FOR LIFE OF PROJECT

## WHAT IS COVERED

PrimeSource Building Products, Inc. ("PrimeSource") warrants that its **PrimeGuard Max**® stainless steel screws will remain rust-free for the serviceable life of the project. PrimeGuard Max® stainless steel screws should be used in more corrosive environments such as swimming pools, docks and coastal areas.

PrimeSource also warrants that the screws will be free from defects in workmanship and materials for the same period. Screw breaking is only considered a factory defect if the tensile strength of the claimed screws is found to be below the stated tensile strength of the screw.

This warranty is extended only to an original purchaser who installed the product at a residence (not commercial premises) in the 50 United States. It is not transferable.

This warranty shall not apply to defects or damages caused by mishandling, improper installation, alteration, removal or re-installation, improper or unreasonable use, maintenance or storage, use of incompatible accessories, accident, impact by foreign objects, fire, acts of God or normal wear and tear.

Deck screws are not considered structural fasteners and should not be used in structural applications. Always consult building codes and structural hanger manufacturers' requirements.

No person is authorized to extend or otherwise modify this Warranty.

## HOW TO OBTAIN WARRANTY SERVICE

To obtain warranty service, send a written notice and photograph(s) demonstrating the defect, together with proof of purchase (retain a copy for your records), to:

If a defect is found to exist, PrimeSource will at its option, either replace the product with a similar screw or with an upgraded screw, such as a stainless-steel screw. This warranty does not cover the costs of labor to remove a defective product or component or install any replacement product or component.
