



Grip-Rite® Moisture PROtection System 15-Year Limited Warranty



GRIP-RITE® MOISTURE PROTECTION SYSTEM PRODUCT WARRANTY

PrimeSource Building Products, Inc. (hereinafter "Grip-Rite®") warrants that, subject to the terms and conditions below, for buildings in which its weather resistive barrier, flashing, and adhesive products (each, the "Product;" more than one, the "Products") are installed in combination with each other as a full building envelope system (the "System"), Grip-Rite® will pay the cost of materials and labor to repair any leaks resulting solely from the failure due to manufacturing defect of one or more Products in the System (the "Warranty"). The "Purchaser" is the owner or owners of the building at the time during which the Products are installed. The Warranty begins on the Purchaser's date of purchase of the Products and lasts for the earlier of fifteen years or the date upon which the Purchaser transfers ownership of the building (the "Warranty Period"). The warranty is non-transferable; it may not be transferred to any other person or entity by the Purchaser.

WARRANTY REQUIREMENTS

For the Product to be eligible for coverage under the Warranty, the Purchaser (and/or his or her installer) must have complied with each of the following requirements:

1. The installed System must include at least one product from each of the following three product categories:
 - a. Weather Resistive Barriers:

 - GRIP-RITE® WEATHERRESISTOR-HP**
 - GRIP-RITE® COMMERCIAL GRADE-D**
 - GRIP-RITE® PREMIUM HOUSE WRAP**
 - GRIP-RITE® HOUSE WRAP-LWE**
 - b. Flashing/Tapes:
 - GRIP-RITE PROWRAP® BUTYL FLASHING TAPES**
 - GRIP-RITE® WINDOW & DOOR PROTECTOR**
 - GRIP-RITE® HOUSE WRAP SEAM TAPE**
 - c. Adhesive:
 - FRANKLIN TITEBOND® WEATHERMASTER SEALANT**
 - OSI® QUAD MAX®**
 - OSI® QUAD® FOAM**
 - OR EQUAL SPEC PRODUCT**
2. Installation of the Product(s) must have been completed in accordance with Grip-Rite's published installation instructions specific to each Product in the System.
3. The Product(s) must have been installed in North America or on an island located in the Caribbean.

CLAIM PROCEDURE

Warranty claims must be made in writing to Grip-Rite® by email at warranty@primesourcebp.com no later than thirty (30) days after a potential claim covered under this Warranty is or should by reasonable diligence have been discovered. Failure to give such notice within the time stated herein shall relieve Grip-Rite® of all liability and any obligation to repair any leak otherwise covered by this Warranty. Warranty claims should include the original proof of purchase of the Products, along with sufficient information to allow Grip-Rite® to evaluate the claim. Grip-Rite® reserves the right to physically inspect the Products subject to the claim and collect samples thereof at their location of installation. WHAT IS NOT COVERED

1. Damage resulting from anything other than an inherent manufacturing defect in the Product, such as installation not in strict accordance with Grip-Rite's installation instructions, if improper installation was the cause of the damage.
2. Damage to the interior or exterior of the building, including, but not limited to, mold growth.
3. Damage resulting from causes beyond normal wear and tear, such as acts of nature, including but not limited to hurricanes, tornadoes, or fire.

THIS WARRANTY SETS FORTH THE ONLY WARRANTY EXTENDED BY GRIP-RITE® FOR ITS ENVELOPE SYSTEM, AND THE PROVISIONS OF THIS WARRANTY SHALL CONSTITUTE THE ENTIRE LIABILITY OF GRIP-RITE® AND THE PURCHASER'S EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY. NO OTHER WARRANTY MADE BY GRIP-RITE® OR ITS AGENTS, WRITTEN OR OTHERWISE COMMUNICATED, WHICH IS NOT CONTAINED OR AUTHORIZED HEREIN, WILL BE RECOGNIZED BY GRIP-RITE®.
